Carlos and Robert Santiago manage an award-winning agency, founded by their mother, that provides translation services for numerous industries.

t's the opposite of sibling rivalry at Para-Plus Translations in Barrington, New Jersey. ## Rutgers Magazine: Who are some of the people you've helped?

**Carlos Santiago**: We do a lot for the legal, medical, and education industries. There are a lot of first-generation parents who are not proficient in English. So school systems will request interpreters when there are meetings about a child.

**Robert Santiago:** We also completed a translation for an American couple looking to adopt a Russian child.

RM: What language is requested most often?

CS: Spanish. We also do a fair amount of business with sign language, Vietnamese, and Indian dialects.

## RM: How does being brothers affect your working relationship?

CS: We've both watched Para-Plus develop from a small thing our mother, Sonia, started in 1980 in the back of our house into the successful company it is today. Working together has actually brought our family closer. The daily interactions we have aren't only about work, but also about our lives.

RM: Para-Plus recently won a contract with the State of Delaware and, in 2011, received the Small Business Growth Success Award from the New Jersey Small Business Development Centers. What are your goals?

RS: Carlos and I don't sit down and say, "We want to make this a \$20-million company." I'm fine with controlled and managed growth, but I think it's more important to keep the values of the company intact.
